Dear Voter,

We have determined that **the signature you provided on your vote-by-mail ballot envelope does not compare to the signature(s) on file in your voter record.** In order for your vote-by-mail ballot to be eligible to be counted, the Signature Verification Statement must be completed and received by the Registrar of Voters at least two days prior to the date the Registrar of Voters certifies the results of this election. California Elections Code section 3019(d)(4).

To meet the statutory deadline, you are encouraged to deliver the Signature Verification Statement to the Registrar of Voters by any of the methods indicated below **by 5:00 p.m. on February 14, 2023.**

You must sign your name below where specified on the **Signature Verification Statement** (Voter's Signature).

Place the **Signature Verification Statement** into a mailing envelope to the Registrar of Voters, 1300 S. Grand Avenue, Bldg. C, Santa Ana, CA 92705. Mail, deliver, or have the completed **Signature Verification Statement** delivered to our office. Be sure there is sufficient postage if mailed.

If you do not wish to send the **Signature Verification Statement** by mail or have it delivered, you may submit your completed **Signature Verification Statement** by fax to the Registrar of Voters at (714) 567-7556 or (714) 333-4488, by email to [ocvoter@ocvote.gov](mailto:ocvoter@ocvote.gov) or return your completed statement to any ballot drop box in the City of Seal Beach or the Registrar of Voter's office before 8:00 p.m. on Election Day.

I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.

I understand that my failure to sign this statement means that my vote-by-mail ballot will be invalidated.
