We recently received your vote-by-mail ballot. However, <u>you did not sign the identification envelope in</u> <u>which you returned your voted vote-by-mail ballot.</u>

In order for your vote-by-mail ballot to be eligible to be counted, the enclosed **Unsigned Ballot Statement** must be completed and received by the Registrar of Voters by 5:00 p.m., two days prior to the date the Registrar of Voters certifies the results of this election. California Elections Code §3019(d)(4).

To ensure you meet the statutory deadline, you are encouraged to deliver the **Unsigned Ballot Statement** to the Registrar of Voters by any of the methods indicated below by 5:00 p.m. on November 27, 2023.

You must sign your name on the **Unsigned Ballot Statement** on the back of this page. Return the Unsigned Ballot Statement in the included postage-paid Business Reply Mail envelope using one of the following methods:

- Mail: Use the postage-paid envelope included or mail to Orange County Registrar of Voters, 1300 S. Grand Ave, Bldg C, Santa Ana, CA 92705
- **Deliver in-person or have delivered** to a Vote Center location in the City of Santa Ana before 8:00 p.m. on Election Day, or the Registrar of Voters' office before November 27, 2023. Vote Center locations can be found at ocvote.gov/votecenter
