Thank you for registering to vote! This Voter Information Guide contains information for the September 14, 2021 California Gubernatorial Recall Election. For additional information, refer to the State Voter Information Guide that will be mailed to you separately. Please take a moment to review your options prior to voting:

- **Convenient Voting at Home:** Every voter will receive an official ballot through the mail in mid-August. You can return your ballot at one of our secure ballot drop boxes, by mail (no postage required), or at one of our Vote Centers. See all of your options at [ocvote.com/options](https://ocvote.com/options).\*
- **Vote Center Voting:** We will be operating 64 full-service Vote Centers. You can vote in-person at select locations beginning September 4<sup>th</sup> – in person voting is open through September 14, 2021. For locations and hours visit [ocvote.com/votecenter](https://ocvote.com/votecenter) (or review in this guide).
- **Election Day is Now 11 Days:** In-person voting at select locations begins September 4<sup>th</sup> and will be open through September 14, 2021. In order to avoid congestion – consider voting your official ballot at home.

This model of voting provides more conveniences to improve the voter experience. Vote Centers provide full voting services, all while allowing you to vote at any location, or use your ballot that you will receive and vote at home instead – see all of the options at [ocvote.com/options](https://ocvote.com/options).

## Can I vote if I register after the registration deadline?

Yes, conditional voter registration extends the 15-day registration deadline in California to eligible voters, allowing them to register and vote provisionally starting 14 days prior to an election and on Election Day, at the Registrar of Voters' office, located at 1300 S. Grand Ave., Bldg C, Santa Ana, 92705 or at any Vote Center.

## Can I vote if I moved to another address in Orange County?

Yes, but you must register at your new address by the deadline above. If you miss the deadline, you may vote and re-register at the Registrar of Voters' office, or at any Vote Center.

## Remote Accessible Vote-by-Mail Ballot

Senate Bill 152 allows any voter to cast a ballot using a certified RAVBM system. The electronic ballot can be downloaded to the voter's computer, marked using the voter's own computer or assistive technology, then printed and returned by following the instructions included with the electronic ballot.

No later than seven days before Election Day, the voter may request the county elections official to send or deliver a ballot that voters with disabilities can read and mark privately and independently pursuant to the federal Help America Vote Act of 2002 (52 U.S.C. Sec. 20901 et seq.).

## Voting assistance available at Vote Centers

Every effort has been made to ensure all Vote Centers meet accessibility standards. Vote Centers will feature:

- Accessible voting machines to mark your ballot
- American Sign Language interpreter via video conferencing
- Curbside voting with paper ballot
- Additional assistance upon request

Voters that are unable to mark a ballot may bring up to two individuals to assist in voting (§ 14282 (b)).

## State law required language assistance information

Translated reference ballots in Tagalog, Farsi (Persian), Hindi, Japanese, and Gujarati of eligible precincts will be available at all Vote Centers in Orange County. You may also cast a Vote-by-Mail ballot in person at a Vote Center. For hours and locations, turn to the Vote Center Locations section of this guide or visit [ocvote.com/voting](https://ocvote.com/voting).

No later than seven days before the day of the election, the voter may request a vote-by-mail ballot in Spanish, Vietnamese, Chinese or Korean, or a translated reference ballot in Tagalog, Farsi (Persian), Hindi, Japanese, or Gujarati for voters in eligible precincts.

## Gubernatorial Recall Election Information

A Special Election will be held on September 14, 2021 to recall Gavin Newsom from the office of Governor.

There are two sections for the voter to consider for the recall:

- The recall question asking if Governor Newsom should be recalled; and
- The contest to select a replacement if Governor Newsom is recalled.

**You do not need to cast a vote for each section. You may cast a vote for either section or both.**

A **“Yes”** vote on the recall question means the voter wants Governor Newsom recalled (removed) from office.

A **“No”** vote on the recall question means that the voter wants Governor Newsom to remain in office.

If a majority of the votes on the recall question are “Yes,” Governor Newsom shall be removed from office and the replacement candidate receiving the highest number of votes shall be declared elected for the remainder of the governor’s term of office. If one-half or more of the votes on the recall question are “No,” Governor Newsom shall remain in office.

The second question on the ballot considers those candidates who are campaigning to replace Governor Newsom, if he is recalled. A voter may vote for one of those candidates who are listed on the ballot or may write in the name of a qualified write-in candidate.

Voters, regardless of their party preference or lack of party preference, may vote for any replacement candidate. The party preference, if any, designated by a replacement candidate is selected by the candidate and is shown for the information of the voters only. It does not imply that the candidate is endorsed by the party or that the party approves of the candidate.

## Estimated Costs to Administer the California Gubernatorial Recall Election

Pursuant to Elections Code section 11108(d), the Department of Finance, in consultation with the Secretary of State and county elections officials, has estimated the costs to administer the recall election of Governor Gavin Newsom to be \$276 million.
