

**CALENDAR OF EVENTS FOR COUNTYWIDE INITIATIVES
JUNE 7, 2022 STATEWIDE DIRECT PRIMARY ELECTION**

This calendar is for County use only. Proponents should seek their own legal advice. Dates with the (*) asterisk indicate those necessary to place a countywide initiative measure on the June 7, 2022 Statewide Direct Primary Election ballot. All section references are to the California Elections Code.

Day Notice of Intent is Filed	Request for Ballot Title and Summary, Notice of Intention, Text of proposed initiative and \$200 refundable deposit filed with the Registrar of Voters. Registrar of Voters forwards text of proposed initiative to County Counsel for preparation of Ballot Title and Summary. §§ 9103, 9105(a)
Within 15 Days after Measure Filed	Ballot Title and Summary of initiative received from County Counsel. § 9105(a)
Day Registrar of Voters Receives Ballot Title	Registrar of Voters forwards Ballot Title and Summary of initiative to proponents. § 9105(b)
June 7, 2021 (E-366)	The clock begins on the 180-day period for the proponents to circulate the petition as soon as they receive the Ballot Title and Summary of the initiative from the Registrar of Voters. NOTE: During this 180-day period and prior to circulation, proponents must publish the Notice of Intention and County Counsel's Ballot Title and Summary in a newspaper of general circulation published in the county. Proof of publication must be provided to the Registrar of Voters prior to circulation. June 7, 2021 is the last day for the 180-day period to begin if proponents wish to have the entire 180-day period for publishing the Notice of Intention/Ballot Title and Summary, providing proof of publication to the Registrar of Voters, and circulating the petition. §§ 9105(b), 9108, 9110
December 3, 2021 (E-186)	Last day for initiative proponents to file 110,673 (10%) valid signatures with the Registrar of Voters. § 9107
January 19, 2022 (E-139)	Last day for Registrar of Voters to verify petition signatures in order to place on ballot. § 9114
January 25, 2022 (E-133)	Anticipated date of Registrar of Voter's submission of certification of sufficiency of an initiative petition to Board of Supervisors (BOS). Options for Board of Supervisors at that meeting include: <ul style="list-style-type: none"> • Order submission of the measure to the voters at the June 7, 2022 Statewide Direct Primary Election. • Request various reports on the effect of proposed initiative(s). The reports shall be presented to the Board of Supervisors within the time prescribed by the Board, but no later than February 24, 2022, 30 days after certification of sufficiency. §§ 9111, 9114, 9118
March 11, 2022 (E-88)	County Counsel's Impartial Analysis and Tax Rate Statement, if applicable, to be printed in the Voter Information Guide are due to the Registrar of Voters. Last day for Text and Direct Arguments to be filed with the Registrar of Voters. §§ 9160, 9162, 9163

March 12, 2022 through March 21, 2022 (E-87 – 78)	Public Review period begins on March 12, 2022 and closes March 21, 2022 , 5:00 p.m. All documents that will be subject to public review will be posted on the Registrar of Voters' website and be available at the Registrar of Voters' office Monday through Friday, 8:00 a.m. to 5:00 p.m. The Text, Direct Arguments, Impartial Analysis and Tax Rate Statement are subject to legal action during this public review period. § 9190
March 21, 2022 (E-78)	Deadline for submittal of Rebuttal Arguments to be filed with the Registrar of Voters. § 9167
March 22, 2022 through March 31, 2022 (E-77 – 68)	Public Review period for Rebuttal Arguments begins on March 22, 2022 and closes March 31, 2022 . The Rebuttal Arguments will be posted on the Registrar of Voters' website and be available at the Registrar of Voters' office Monday through Friday, 8:00 a.m. to 5:00 p.m. Only Rebuttal Arguments are subject to legal action during this public review period. § 9190
April 28, 2022 (E-40)	Voter Information Guide mailing begins approximately this date. Mailing completed by May 17, 2022 . § 13303(a)
May 9, 2022 (E-29)	Registrar of Voters begins mailing Vote-by-Mail ballots. § 3001
May 17, 2022 (E-21)	Last day to mail Voter Information Guides. § 13303(a)
May 23, 2022 (E-15)	Last day to register to vote for the Statewide Direct Primary Election. § 2102
May 24, 2022 (E-14 – 0)	Conditional Voter Registration period. During the 14 days prior to Election Day and including Election Day, an individual can go to the office of their county elections official, a satellite office, or to a Vote Center to conditionally register to vote and vote a provisional ballot. §§ 2170
May 28, 2022 (E-10)	Beginning 10 days before the day of the election and continuing daily up to Election Day, select Vote Centers are open to the public. § 4005
June 4, 2022 (E-3)	Beginning 3 days before the day of the election and continuing daily up to Election Day, additional Vote Centers are open to the public. § 4005
June 7, 2022 (E-0)	Election Day. Vote Centers open from 7:00 a.m. to 8:00 p.m. Ballots will be centrally counted at the Registrar of Voters' office. §§ 1000, 14212
July 7, 2022 (E+30)	Registrar of Voters will certify on or before this date. § 15372
